ABOUT THE NATIONAL SEMINAR

THEME OF THE SEMINAR

Keshavanand Bharti case is a landmark in Indian Constitutional law history which has lasting impact on the Indian legal system. The judgement in this case has completed 50 years on 24 April 2023. The A.K. Gopalan case, Sri Sankari Prasad case, Sajjan Singh case and I.C. Golak Nath case are precursors to **Keshavanand Bharti** case judgement and have played an important role to establish the groundwork for this case. 24th Constitutional Amendment sought to curtail the powers of judiciary and limit the scope of judicial review and 25th and 29th Constitutional Amendments sought to limit the fundaments rights of citizens and gave Parliament the power to amend any part of the Constitution. The judgement in this case upheld the basic structure doctrine and placed limits on the power of the Parliament to amend the Constitution. This case is remembered as a key figure in the fight to uphold the principles of democracy and the rule of law in India. It is significant as it established the doctrine of basic structure of the Indian Constitution. This doctrine is a check on

the power of the Parliament to amend the Constitution and ensures that Constitution is a living document which is responsive to the changing times while preserving its fundamental values and principles. The judgement affirmed the supremacy of the Constitution, separation of power and independence of judiciary and laid down several principles that have become the bedrock of constitutional law in India. The court held that the power of Parliament to amend the Constitution under Article 368 is not unlimited and it cannot alter the basic structure of the Constitution
